Rodney Dixon QC has a diverse practice in the UK and globally in international law, public law, inquiries, compliance and regulation, and human rights. He appears on behalf of Governments, serving and former Heads of State, politicians, military commanders, individual complainants and defendants, international organisations, companies and businesses, NGOs, and victim groups. He specialises in public international law, international criminal law, and human rights and civil liberties before all international, regional and national courts. His expertise lies in cases concerning foreign relations, inter-State disputes, the armed forces, international prosecutions and defence, public inquiries, universal jurisdiction, claims with international components, mediation and arbitration, cross-border proceedings, asset recovery, extradition and mutual assistance. He is described in Chambers and Partners “as an exceptional barrister with clients on every continent” and “respected for his excellent advocacy skills and strong client care”.

Rodney has particular experience acting for Governments undertaking national investigations and restorative justice programs that comply with international standards. He has, for example, represented the Government of Kenya before the ICC in respect of charges brought against the President, Vice President and others (including in respect of asserting national sovereignty over the cases, disclosure requests, national security issues, official immunity, and relations with international organisations) – none of the cases have



proceeded at the ICC; and the former Government of Afghanistan in seeking a deferral of the ICC investigation to the national system – an agreement was being sought with the ICC at the time the Government changed. He has also acted for the UK Government in respect of allegations against UK armed forces arising from the Iraq conflict – the ICC Prosecutor decided not to proceed on the basis of the national investigations being conducted in the UK. He advised the Government of South Sudan in advancing the national criminal justice system and truth building mechanisms with a view to creating and strengthening national justice institutions. When Zimbabwe faced international calls for an investigation Rodney was appointed by the President of Zimbabwe to serve on the national Commission of Inquiry into post-election violence that was chaired by the former President of South Africa.

Rodney's work covers all international criminal courts; UN proceedings, claims, and special procedures; actions before the International Court of Justice (ICJ); cases at the European Court of Human Rights; applications before the African Commission and African Court on Human and Peoples' Rights; Privy Council cases; bilateral investment treaty matters; territorial and border disputes; public inquiries and investigations; World Bank Sanctions Board proceedings; land claims and reparations; corporate compliance and regulation; detentions abroad; Interpol and international and European arrest warrants; and, private international law cases.

He is widely recognised as a leading counsel and expert for all international criminal courts and regularly appears before the ICC and other international criminal courts like the ICTY and ICTR for individual defendants, States, and victims, including on behalf of the UK Government; the Government of Afghanistan; the Government of Kenya; the Comoros Government; the former Government of Egypt; the Government of Rwanda; the Prime Minister of Kosovo; Mr. Abdullah Al-Senussi; victims of the Gaza Flotilla raid; and, interveners in the Sudan ICC Situation in the case concerning President Al Bashir, and victims from Darfur. He is one of a handful of lawyers who has both prosecuted and defended in international courts. He has acted and advised before other hybrid courts including the Special Court for Sierra Leone, the Iraqi Special Tribunal, the Extraordinary Chambers in the Courts of Cambodia, the Special Tribunal for Lebanon, and the War Crimes Division of the High Court of Uganda.

Rodney is highly respected in the field of public inquiries and investigations. He was appointed as a Commissioner on the National Commission of Inquiry into post election violence in

Zimbabwe following the elections there in August 2018. He has previously been instructed in several inquiries including, the Presidential Commission of Inquiry into Disappeared Persons in Sri Lanka; for victims in the Jamaican Commission of Inquiry into the Tivoli Gardens killings; and, as part of the counsel team for the UK Ministry of Defence in the Baha Mousa public inquiry. He was instructed by the Government of South Sudan as an international adviser in respect of legal and judicial reforms under the 2015 Peace Agreement following the civil war. He has advised the Government of Qatar regarding the land, air and sea blockade imposed on the country in 2017. His cases before the European Court of Human Rights have included for the Government of Georgia concerning the conflicts in South Ossetia and Abkhazia and for the Ukrainian Government regarding the occupation of Crimea and Eastern Ukraine. He has acted in cases and hearings before the African Court and African Commission on Human and Peoples' Rights including in relation to mass death sentences imposed in Egypt. He has represented many persons arbitrarily detained abroad, including the former President of South Korea, prominent Moroccan journalist Taoufik Bouachrine, and women detained in Saudi Arabia. Rodney is currently acting for Durham University academic, Matthew Hedges, who was held in solitary confinement in the UAE.

Rodney is the co-author of the leading textbook *Archbold International* on the law, procedure and practice of all international criminal courts, now in its 5th Edition (Sweet & Maxwell). It has been described by Justice Richard Goldstone, the former Chief Prosecutor of the ICTY and ICTR, as the book that "*will always be open on the desks in offices*" at the courts in The Hague.

Rodney has advised and lectured in the fields of bribery and corruption, money laundering, and cybercrime, with particular emphasis on the cross-border aspects and inter-State co-operation. He regularly lectures at conferences and seminars on international law, human rights, and civil liberties topics. He is a Senior Research Fellow at the Department of War Studies, King's College. He has lectured at the UK armed forces Joint Services Staff College on the law of armed conflict, and was an instructor on the Canadian Armed Forces Law of Armed Conflict Course - Land, Naval and Air Operations. He has trained Judges and lawyers on international law, rule of law and human rights topics in several jurisdictions including in Sri Lanka, Mexico, Rwanda, Uganda, Sierra Leone, Cambodia, Lebanon, Bosnia, Nigeria, Serbia, Kosovo, Romania, Croatia, Bulgaria, Denmark, Finland, Italy and Germany.

He is often interviewed as an expert commentator including by the BBC, SKY News, Al Jazeera, RT News, and TRT World on topics such as the prosecution of UK soldiers serving abroad, arrest warrants for foreign leaders and universal jurisdiction, business responsibilities and compliance, border disputes, detentions abroad, and the developments in human rights cases around the world.

WGEID remains seized of the case and has been requested to take urgent steps to secure Princess Latifa's release.

The UK Government did not respond formally to the UN Special Rapporteurs. The Communication will now be presented to the UN Human Rights Council.

During the pre-colonial and colonial era in Kenya, the Kipsigis and Talai peoples were progressively evicted from fertile land in

Kericho County to make way for European settlers. The Kipsigis and Talai were forcibly displaced and made to live in overcrowded and poorly resourced reserves. The Talai peoples were deported and internally exiled to Gwasi, where living conditions were devastatingly harsh.

The conclusions of the UN Special Rapporteurs build on earlier findings by the Kenyan National Land Commission. In 2018 Counsel for the victims submitted an application to the National Land Commission on behalf of the victims, and represented them at hearings of the Commission. In 2019, the Kenyan National Land Commission determined that the Kipsigis and Talai peoples were victims of historical land injustices and made recommendations for reparations to the UK and Kenyan Governments.

The Kipsigis and Talai peoples of Kericho County continue to pursue their claims for truth, justice and reparations.

Torture victims Dr Al-Jaidah and Mr Al-Hammadi send formal notification of civil claims to Abu Dhabi Media Company PJSC

The civil claims follow successful fairness and privacy complaints submitted to Ofcom in relation to the broadcast of their forced confessions. In November 2020 Ofcom found that Abu Dhabi Media Company PJSC had violated the fairness and privacy provisions of the Broadcasting Code. Following Ofcom's Adjudication Decisions and whilst sanctions for breaches were being considered, Abu Dhabi Media Company PJSC

The mobile phone is potentially relevant to the Special Rapporteur's investigation as Mr Bouachrine has stated that it contains text messages sent between himself and Mr Khashoggi about their safety and security in the period prior to Mr Khashoggi's murder and Mr Bouachrine's arrest. Both of them as leading human rights journalists had been highly critical of the Saudi government and its policies. Mr Bouachrine's appeal proceedings continue in Casablanca.

ICC Appeals Chamber hears landmark appeal

The District Court dismissed the case in the first instance on the grounds that Mr Barak as a former state official enjoys official immunity from suit. The matter has never been determined by the California Court of Appeal or the US Supreme Court. The well-known Pinochet case in the UK that denied immunity to the former Chilean dictator is one of several international precedents relied on.
