In recent years, he has also appeared in a series of high-profile inquests and inquiries, including the 7/7 inquests, the Hillsborough inquests, the Litvinenko Inquiry, and the Independent Inquiry into Child Sexual Abuse. He has experience of representing corporate bodies in such proceedings – he acted for the operators of the Manchester Arena in the Manchester Arena Inquiry and for Pinterest in the recent Molly Russell inquest.

He is currently instructed as Leading Counsel to the Dawn Sturgess Inquiry (relating to her death in Salisbury from Novichok poisoning) and also as one of the Counsel to the UK Covid-19 Inquiry. In addition, he is acting for the Ministry of Defence in the recently announced Independent Inquiry Relating to Afghanistan.

Acted as Counsel to the Inquests in the inquests into the deaths of the four young men killed by Stephen Port, the so called 'Grindr Killer'. The substantive hearings took place over 10 weeks in Barking Town Hall, towards the end of 2021.

Dawn Sturgess Inquest

Acting as Counsel to the Inquest into the Death of Dawn Sturgess, who died in 2018 as a result of Novichok poisoning in Salisbury. The proceedings will be converted into a public inquiry.

Manchester Arena Inquiry

Acting for SMG, the company which operates the Manchester Arena, in the public inquiry into the deaths of those killed in the May 2017 terrorist attack. In hearings that took place during the second half of 2020, the Inquiry conducted a substantial investigation into security arrangements at the Arena at the time of the attack.

Litvinenko Inquiry

7/7 Inquests

Acted as Junior Counsel to the Inquests in to the deaths of those killed in the 7/7 bombings.

Administrative Law

Andrew continues to act, primarily for government clients, in public law challenges in the Administrative Court. Many of the cases involve issues of national security and closed material procedures. He also conducts similar cases before the Special Immigration Appeals Commission and the Investigatory Powers Tribunal.

Personal Injury

In the early years of his practice, Andrew had a purely common law / PI practice and was therefore routinely involved in a variety of PI cases, including often being led in larger cases. In more recent years, his practice has moved more towards public law, but Andrew has continued to be involved in civil actions.

In 2016/17 Andrew was instructed in a high value and complex damages claim brought on behalf of a young man who had been left very severely disabled following complications of diabetes. He was living in a probation hostel at the time and the claims of negligence were brought against the Claimant's treating doctors, the Probation Service (whom Andrew represented) and the company that ran the hostel. Following pleadings and the exchange of expert evidence, the claim was eventually settled with contributions from each of the three defendants.

Andrew has also acted for government clients in large scale and long-running High Court litigation relating to allegations of misfeasance / torture, including the Belhaj case about rendition of terrorist suspects to Libya and also the recent claims (including personal injury claims for damages) brought by a group of Cypriot EOKA veterans alleging mistreatment dating from the 1950s. Both cases were settled following mediation.

Andrew is currently representing the Foreign Office in the civil damages claims brought by the victims of the Tunisian terrorist shooting in 2015, although his role in that case has been limited to disclosure issues (the FCO is not a defendant).
