Counter Fraud

James is regularly instructed by insurers combatting motor insurance fraud rings and has been appointed as Lead Counsel in an Insurance Operation implemented by one of the UK's leading insurers which has reserves of over £3.5M.

His counter fraud practice also includes acting for motor insurers in single stand-alone claims involving: fraudulent credit hire claims; staged/induced accidents; fictitious accidents; and LVI/LSI cases. James is regularly instructed by insurers in personal injury claims in which dishonesty is suspected and has obtained declarations of fundamental dishonesty in Multi-Track cases.

Personal Injury

James has been appointed as personal injury panel counsel for one of the UK's largest employers. He has extensive experience in Multi-Track cases involving both complex injuries and fatalities. He is regularly instructed at all stages of litigation, from the provision of preliminary advice and the drafting of pleadings, through to JSM and trial. Counter Fraud

James is ranked as a Leading Junior by Chambers and Partners for his counter fraud work for motor insurers. He conducted his first fraud trial in 2012 and has since been regularly instructed in cases involving fraud and/or fundamental dishonesty. He has obtained numerous declarations of fundamental dishonesty in both Fast and Multi-Track cases.

Motor Insurance Fraud Operation (ongoing)

J v C

Turkmen v 1 Davies 2 Another

Personal Injury

He has been appointed as personal injury panel counsel for one of the UK's largest employers and regularly deals with both complex injury and fatal accident cases.

A significant proportion of his work is paper based, including the drafting of defences, counter-schedules, Part 35 questions, Part 18 questions, and, opinions on prospects and/or quantum. James also represents clients in Joint Settlement Meetings (JSMs) and mediations as well as at trial.

Notable Personal Injury cases

B v D

For the Defendant – Personal injury claim for £1.3M involving orthopaedic, neurological and psychological injuries. Substantial claims for care and accommodation. Conferences with experts, advising, drafting and settlement at JSM for £600k.

M v 1 D 2 Hastings

Credit Hire
