Juliet has a wide-ranging practice spanning public law, group litigation and commercial law, inquests and inquiries, international law, extradition, and costs and litigation funding. Many of her cases involve issues at the intersection of those areas.

She is ranked as a *'Rising Star'* in Administrative Law, Human Rights, International Crime and Extradition in Legal 500 and as *'Up and Coming'* in Inquests and Inquiries in Chambers and Partners. In August 2022 she was appointed to the Attorney General's C panel of counsel.

Juliet is often instructed in high profile and complex litigation, regularly undertaking work well beyond her level of call. Current and recent highlights of her practice include:

## Public Law

---

Juliet is recognised as a 'Rising Star' in the field of Administrative Law and Human Rights by Legal 500. She is a member of the Attorney General's C panel of counsel.

She is frequently instructed in high-profile and heavy judicial review claims, and is regularly retained by government departments to advise on the design and implementation of flagship policies and legislation.

She has a particular interest in parliamentary privilege, judicial review procedure, and claims by companies alleging A1P1 interference.

---

At the conclusion of the inquests (which lasted for six weeks), the jury identified "catastrophic" systemic failings in the national and local gun licensing process, and the Coroner issued PFD reports to a record 48 recipients including the Home Secretary, the Lord Chief Justice and every Chief Constable in England & Wales.

## Collective Redress

---

Juliet has acted in a number of group litigation cases, including competition law claims, environmental damages claims, and public law claims by test claimants.

Her chapter on collective redress in *Zuckerman on Civil Procedure: Principles of Practice* (4th Ed. Sweet & Maxwell, 2021) was cited by the Supreme Court in *Lloyd v Google LLC* [2021] UKSC 50 in support of the Court's interpretation of the 'same interest' requirement in representative actions.

She is currently advising on possible reforms to the UK's class action regime as part of a working group of practitioners and academics convened by the Collective Redress Lawyers Association (CORLA).

She is regularly invited to speak at conferences on public international law issues, and has previously addressed events at the UN Human Rights Council in Geneva on alleged breaches of international law by GCC states.

## **Extradition & Interpol**

She is experienced in dealing with the full range of issues arising in Part 1 cases, and has acted in a number of cases under Part 2 of the Extradition Act 2003.

She is particularly well-versed in human rights issues arising out of detention in the Gulf states, and recently advised in relation to a prospective Kuwaiti request arising out of politically motivated allegations of fraud made by the Gulf Investment Corporation.

---

She is especially well-placed to advise on complex procedural issues, including service outside the jurisdiction, disclosure, security for costs, and freezing orders. She is the general editor of *Zuckerman on Civil Procedure: Principles of Practice* (4th Ed. Sweet & Maxwell, 2021), which is frequently cited by the High Court, Court of Appeal and Supreme Court, and is currently co-authoring a book on the theory and practice of disclosure around the common law world.

## Costs & Litigation Funding

---

Juliet advises and acts in cases raising a wide range of costs law issues.

Her experience includes costs budgeting and CCMCs, appeals against costs orders, applications for wasted costs and non-party costs orders, challenges to legal aid determinations, and detailed assessments.

She is particularly well-placed to advise on costs and funding in group litigation, including identification of common and individual costs, compatibility of funding arrangements with the Damages-Based Agreements Regulations 2013, risks to third party litigation funders, and security for costs applications.

During the legal year 2016–17, she was Judicial Assistant to Lord Justice Jackson at the Court of Appeal, and worked closely with him on his 2017 Supplemental Report on Fixed Recoverable Costs (which led ultimately to the introduction of the new CPR 45 regime in 2023).
