Nicholas Chapman is recognised as one of the country's leading barristers across his practice areas.

He has a very broadly based practice with a particular emphasis on public law, public inquiries and inquests. He is also well known for his work in a number of related practice areas, including regulatory and disciplinary, tax, civil-criminal crossover, health and safety and environmental law, and public international law.

He is consistently ranked as a leading barrister by the main legal directories, and is one of only a handful of members of both the Attorney General's "A panel" of counsel and of the Equality and Human Rights Commission's "A panel" of counsel.

Nick's cases are generally important, complex and high-profile, and often raise cutting edge issues. In recent years his experience has included:

- representing the British government in a number of judicial review challenges concerning its response to the Covid-19 pandemic, including in relation to the hospitality curfew, attendance at weddings, and the "Moonshot" mass asymptomatic testing programme
- acting for all seven defendants in claims alleging British government and intelligence agency involvement in extraordinary rendition and torture (Belhaj & Boudchar v Jack Straw, MI6, MI5 & others) and in a range of other cases in the national security and counter-terrorism field
- representing the British government in relation to Operation Pitting, the 2021 evacuation of Afghanistan, and the subsequent Taliban takeover
- acting for the Home Secretary in the Supreme Court appeal concerning the lawfulness of the statutory fees regime for British citizenship applications, now the leading authority on principles of statutory construction (R (PRCBC and O (a child)))
- appearing in the leading domestic case on the scope of the UN Refugee Convention and the circumstances in which refugee status can be cancelled or withdrawn (JS (Uganda))
- appearing in one of the leading cases on the circumstances in which a friendly state's Article 3 assurances should be rejected (Devani)
- representing the Parole Board in a series of judicial review claims concerning the release of life- or extended sentence prisoners (including R (McCourt) v Parole Board)
- representing DEFRA in a series of judicial review challenges to the Government's badger culling programme

Nick has appeared at every level of the domestic court, tribunal and coronial system, from the magistrates and First-tier Tribunal to the Supreme Court. He has acted in a large number of reported cases, and is regularly brought into cases at the appeal stage.

His early years of practice were spent in the criminal courts, and he remains well placed to advise on cases at the interface between criminal and civil law. Many of his cases have an international dimension and he is accustomed to working with foreign lawyers and as part of multi-disciplinary teams.

His clients include Government departments and agencies, the Security and Intelligence services, HMRC, the SFO, the National Crime Agency, multinational corporations and financial institutions, national sports bodies, and Magic Circle and other leading firms of solicitors.

Expertise

Public Law

Nick is regarded as one of the country's leading public law barristers, regularly acting in the some of the most complex, important and high-profile cases in the field.

His practice covers the full range of public and regulatory law matters, including (by way of example) human rights and civil liberties, constitutional law, national security and counter-terrorism, public procurement, criminal justice and penal law, EU law, discrimination, public international law, tax, nationality, immigration and asylum law and professional discipline.

His cases are often at the cutting edge of legal developments, and he has appeared in many reported cases and at all levels of the domestic court and tribunal system up to and including the Supreme Court.

He is one of only a handful of members of both the Attorney General's "*A panel*" of counsel and of the Equality and Human Rights Commission's "*A panel*" of counsel.

Judicial review claim concerning the citizenship status of British-born children of EU citizens.

Representing HM Government in challenge concerning Operation Pitting, the evacuation of Afghanistan in August 2021, and its subsequent policy towards those remaining in Afghanistan.

Leading authority concerning the nature of the public protection test.
