### Personal Injury

## Collective Redress

---

He was recently instructed by Pogust Goodhead, acting on behalf of claimants in *Município de Mariana and Ors v BHP Group Plc and Anr*, which concerns the Fundão Dam collapse in November 2015. The claimants include individuals, municipalities, businesses, utility companies, churches, and indigenous communities affected by the collapse of the dam.

## Health & Safety

Nick has experience in health and safety litigation arising primarily from his personal injury practice but additionally through assisting clients facing health and safety prosecutions. Lead by Keith Morton KC, he was recently instructed to represent Transport for London at a sentencing hearing before Fraser J at the Old Bailey. The prosecution arose out of a tragic tram crash on 09 November 2016 in Croydon, which resulted in the deaths of seven passengers and many injuries.
